Executive summary

The Green City Action Plans (GCAP) under the Green Cities programme of the European Bank for Reconstruction and Development (EBRD) aims to help cities address their environmental challenges and adapt to climate change. The EBRD secures the funding for the elaboration of the plans, and assists in the development of the plans, while the municipalities, along with local and central stakeholders are responsible for their implementation.

One of the main four objectives of this project is to create ownership of the Bucharest GCAP by encouraging a broad civil participation in its development. Hence, stakeholders' engagement is essential firstly for an accurate understanding and definition of the needs and environmental challenges faced by the local communities and, ultimately, for assessing the feasibility for implementation of the actions proposed by the consultants.

The overall objective of this project is to support the Municipality of Bucharest in developing and approving a Green City Action Plan. The Project's objectives are:

- 1. Assist the city of Bucharest, stakeholders and its citizens in **developing ownership** of the GCAP by encouraging a broad civil participation for the GCAP development and awareness raising.
- 2. Assist the city of Bucharest in identifying and prioritising its environmental challenges.
- 3. Prepare a list of **infrastructure investments** that address those challenges and which can be implemented and managed by the City, regional and national government, utility companies, and other stakeholders.
- 4. Prepare a list of **policies, regulations, guidelines and other legal, administrative and managerial measures** that address the priority environmental challenges and support the implementation of infrastructure investment projects.

The **Stakeholder Engagement Plan (SEP)** designs the approach towards engaging all interested parties, including the mapping of the stakeholders and their roles, methods of communication and engagement and the desired outcomes.

Stakeholder engagement is essential for the development of durable, effective, and pragmatic relationships which are essential to the successful management of the environmental and social risks of the project as well as its associated impacts.

SEP aims to inform stakeholders about potential environmental and social impacts related to the project, through an appropriate disclosure of information, to ensure that their perceptions of the proposed actions are as fair as possible, and through a constant consultation with them to resolve any concerns or complaints they may have. It is a guidance document that maps the main categories of stakeholders who will be significantly engaged in the development and implementation of GCAP. Furthermore, this SEP outlines how the municipality intends to communicate with the identified stakeholder groups who may be affected by or interested in the actions developed in Bucharest GCAP. Thus, it focuses on:

- the identification of the stakeholders who may be affected and may have an interest in GCAP stakeholders mapping;
- establishing engagement methods that are appropriate for each identified category of stakeholders;
- documenting previous engagement activities and feedback with stakeholders;
- the development and the implementation of future stakeholder engagement programs and engagement methods;
- monitoring and evaluation of the engagement actions;



• roles and responsibilities.

This SEP also sets out the planned schedule for the disclosure of project information and the stakeholder consultation events, as well as the methods for registering and addressing comments and grievances from various stakeholders.

The SEP is a "living" document that can be progressively developed through updated versions in accordance with the phases of the GCAP. The document will be made public on the municipality website, and it will be accessible to local communities as part of the project disclosure program and policy as described below.

Bucharest municipality, the EBRD and the team of consultants will respect the right to privacy of the interested parties that are relevant to this SEP regarding information relating to personal or private activities and protecting communications, including complaints.

The SEP will ensure that sufficient time is given for feedback rounds, to ensure that the GCAP is aligned with the expectations of the City, both in terms of content and format. The last round of feedback will be enlarged to all stakeholders actively involved in the process and anyone who wishes to comment via the website of the Municipality of Bucharest. A deadline for feedback will be clearly communicated to ensure the process is effective.

1. Stakeholder identification and engagement methods

Stakeholder mapping, i.e. identification and classification, is a continuous process throughout the duration of the project, with some parties being identified in the initial phases of implementation while others will be added as they gain influence or interest in the project. Stakeholders' identification will reflect a collaborative, multi-disciplinary endeavour refined by substantial input, active participation, and recommendations from the City. Stakeholders are individuals or organizations, public or private, that:

- (1) can influence the decision making of the GCAP and implementation of the actions;
- (2) are likely to be affected by the GCAP actions, directly or indirectly, and
- (3) have an interest in the GCAP.

Bucharest has many environmental problems like air pollution, transportation, green spaces, water and heating systems, municipal solid waste or the old buildings which are not energy efficient. The Municipality is directly interested in solving these problems. However, for each of these challenges there are different stakeholder groups that must be involved, consulted and empowered.

Risks related to stakeholder engagement include insufficient consultations or reputational losses that could come from poor stakeholder relations. Ultimately, they amount to a lack of ownership for and motivation of implementing the actions. Hence, good stakeholder relations are a prerequisite for good risk management.

In order for GCAP to have the desired environmental and social impacts, consultation will not be a single conversation but a series of opportunities to create understanding about the project among those who will be likely affected or interested. Thus, the project team will learn how these external parties view the project and its associated risks, impacts, opportunities, and mitigation measures.

Listening to stakeholders' concerns and feedback can be a valuable source of information that can improve project design and outcomes and help the City identify and control external risks. It can also form the basis for future collaboration and partnerships. For stakeholders, the consultation process is an opportunity to get information, as well as to educate the City's staff about the local context in which a project will take place, to raise issues and concerns, ask questions, and potentially help shape the project by making suggestions to considered and responded to.

Considering the fact that the Romanian stakeholders are mostly reactive rather than proactive, the City will need to closely work with the consultants in order to apply effective strategies for engaging them and to provide upfront concrete proposals to be discussed, especially when it comes to their views on the current situation and the prioritization of the challenges and of the actions.

The Communication Department of the Municipality shall facilitate the process of stakeholder engagement for the consultants.

In the current context of the project, several stakeholders have already been identified and others will be included in the future stages of the project. The stakeholders that have already been identified are described below.

Bucharest Municipality

Being the beneficiary of this project, the Bucharest Municipality is the most important stakeholder. It is part of the local and regional governance structures, and also holds a large amount of technical expertise on the various sectors of focus to the GCAP, ranging from local transportation and public services to green spaces and social services.



Therefore, the implication of the stakeholders internal to the Municipality is crucial for the feasibility and necessity of the actions proposed by GCAP and ultimately for its implementation. In addition, they are the most likely to share valuable inputs to the consultants, on all chapters of the project.

The Technical Experts Group within the City will provide technical inputs and review the deliverables prepared by the Consultant. This expert group will consist of representatives from municipal departments dealing with city finances and investment or development planning, emergency response and civil protection, climate change, disaster risk reduction and preparedness, and most critically representatives from utilities or municipal service companies operating at city level. The members may overlap with those involved in the Steering Committee.

To oversee and steer the GCAP process, the City will establish a GCAP Steering Committee. This Committee will provide strategic oversight and input. It will consist of senior representatives/heads from relevant municipal departments including from finance, communications, sectoral departments, and offices responsible for promoting the City's sustainable and resilient development. Members from other public agencies, utility companies, businesses, NGOs, universities, academic institutions, and other relevant organisations may be included to the Steering Committee, responsible for:

- Accepting deliverables prepared by the Consultant.
- Support the Consultant to access information held internally and, where possible, external stakeholders, to carry out analysis and to prepare actions.
- Review and approve selection of Green City challenges, visions, strategic goals, and actions.
- Inform citizens on the progress of the GCAP development through its website, social media or newsletters.



National / Regional Government

Government regulators have great influence over the project and should be involved in the consultations from the beginning. The successful implementation of GCAP depends on integrating their position within the proposed actions.

In many cases, strategic decisions related to location, capacity or other key project alternatives are determined through the strategic planning functions of the state prior to the involvement of the private sector. Such government planning processes may involve stakeholder engagement to varying degrees, and entering into dialogue with the governmental agencies responsible for these higher-level stakeholder engagement processes can be an opportunity to influence decisions and the quality of the project.

The last stakeholder consultation, as part of the 30-day public disclosure of GCAP, is of great importance and will validate the entire project. All comments and proposals received will be organized in a registry for comments. This will be directed to the team of consultants to be addressed in an effective and collaborative fashion, in order to cover all the comments and suggestions received, either by amending the GCAP draft or by answering and motivating why the comment or suggestions is not incorporated in the plan.

GCAP Bucharest: Stakeholders engagement plan



The approach to stakeholder engagement described in this document ensures confidential treatment of feedback and complaints, protects stakeholders' personal data and is designed to be an accessible tool. The SEP will be monthly reviewed to assess whether:

- The stakeholder list remains appropriate.
- Engagement activities are appropriate for different groups of stakeholders.
- The frequency of activities is sufficient.
- Inquiries are being adequately dealt with.



Annex 1: Stakeholder engagement regulatory framework and existing practices

At the national level, there are no specific requirements for the preparation of a Stakeholder Engagement Plan. However, some provisions for engaging stakeholders are included in several regulations and procedures, as explained below:

- The Romanian Constitution stipulates in article 31 (1) that "a person's right of access to any information of public interest cannot be restricted" and in Article 31 (2) that "public authorities, depending on their competence, will be obliged to provide correct information to citizens regarding public matters and matters of personal interest";
- Law no. 86/2000, for the ratification of the Convention on Access to Information, Public Participation in the Decision-Making Process and Access to Justice in Environmental Matters, signed in Aarhus on June 25, 1998 (Aarhus Convention);
- Law no. 544 of October 12, 2011 on free access to information of public interest also defines the details of free access of any person to any information of public interest which, as a general principle, constitutes one of the fundamental principles of the relationship between citizens and public authorities in accordance with The Romanian Constitution and the international commitments ratified by the Parliament of Romania. The same law stipulates that public authorities or institutions will ensure that access to information of public interest will be ensured ex officio or upon request, through the public relations department or through a person designated for this purpose;
- Government Decision no. 878/2005 on the right of access to environmental information transposes Directive EU 2003/4/CE of January 28, 2003 (regarding the right of access to environmental information and repealing Directive no. 90/313/CEE) and ensures the right of access to environmental information held by or for public authorities and establishes the conditions, general terms and ways of exercising that right;
- Government Emergency Ordinance no. 195/2005, relating to environmental protection, amended periodically, clearly states in Article 5 that the State recognizes the right of every person to a "healthy and ecologically balanced environment" and for this purpose, the State guarantees, inter alia, the right of any person to be consulted during an environmental decision-making process (i.e. legislation, plans and programmes) and the right of access to justice;

The EBRD's Environmental and Social Policy defines stakeholder engagement as an on-going process which involves the following elements: (i) stakeholder identification and analysis; (ii) stakeholder engagement planning; (iii) disclosure of information; (iv) meaningful consultation and participation leading to the client's incorporating into its decision-making process the views of the affected parties on matters that affect them; (v) an effective feedback and response mechanism, and (vi) ongoing reporting to relevant stakeholders. The process of stakeholder engagement should begin at the earliest stage of project planning and continue throughout the project life.

An essential element in the stakeholder engagement process, to ensure meaningful and effective consultation process, is the careful identification of all involved stakeholders and the examination of their concerns, expectations, and preferences. Special attention should be paid to the identification of vulnerable stakeholders. The engagement with these stakeholder groups needs to be planned and managed with special care.

This SEP for Bucharest GCAP has been developed in line with these requirements.
